Rotary Mottoes:

The first motto of Rotary International, He profits Most Who Serves Best, was approved at the second Rotary

Convention in 1911. The phrase came from a 1910 speech by a Chicago Rotarian, Art Sheldon, who said, "He profits most who serves his fellows best." At about the same time, Ben Collins, president of the Rotary Club of Minneapolis, Minnesota, commented that the proper way to organize a Rotary club was through the principle his club had adopted: Service, Not Self. These two slogans, slightly modified, were formally approved as the official mottoes of Rotary at the 1950 convention in Detroit: He Profits Most Who Serves Best and Service Above Self. The 1989 council on Legislation established Service Above Self as the principal motto of Rotary, since it best explains the philosophy of unselfish volunteer service. In 2004, the secondary motto was changed to They Profit Most Who Serve Best.
